Bidding is open to all eligible as per Section V of bidding document..
2. **Birgunj Metropolitan City** invites electronic bids from eligible bidders for the Collection of Solid Waste and Drain Cleaning Services for Birgunj Metropolitan City, this bidding is open only to prequalified Bidders Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the

provision of ITB 21 of the Bidding Document. More Details on the services are provided in the Terms of Reference(Section 7).

3. The Request for Proposals(RFP) has been addressed to the following shortlisted Consultants:(BDEC-ENVIROVISIONJ/V, Gathaghar),(N.K. International Construction pvt.ltd,Bharatpur-4,chitwan) and (ESRC-Signature JV, Kupandol, Lalitpur). Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Birgunj Metropolitan City, Birgunj ,Parsa or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. It is not permissible to transfer this invitation to any other firm, such as Consultant's parent companies, subsidiaries and affiliates. The Client will reject a Proposal if the Consultant drops a JV partner without the Client's prior consent, which is given only in exceptional circumstances, such as blacklisting of the JV partner or occurrence of Force Majeure.
5. A firm will be selected under [QCBS system] and procedures described in this RFP. Bidder must submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp.
6. Pre-bid meeting shall be held at Birgunj Metropolitan Office,Birgunj,parsa on 2080/11/06(18th February 2024) 14:00 PM .If Bidder's Representative is not present at Bid opening time,Opening of bid won't be postponed.
7. Electronic bids must be submitted to the office of Birgunj Metropolitan City through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2080/11/17 (29th February 2024). Bids received after this deadline will be rejected.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Technical Bids pass Marks is 60 marks after conversion on 80marks weightage (Technical fail bidders price bid will not open). Only who have been determined as being qualified for award to attend the opening of the Price Bids. The date, time, and location of the opening of Price Bids will be advised in writing by the Employer. Bidders shall be given at least 7 days notice for the opening of Price Bids.
10. The Performance Security amount is: 5% of total fiscal year bidding amount and must be valid for a period of 61 Months.
11. The office reserves right to accept or reject any or all bids without assigning reasons, whatsoever.
