3. Bidder must submit their bid electronically and can download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below .

4. Pre-bid meeting shall be held at Birgunj Metropolitan City, Birgunj, Parsa at 2077/06/19 (5<sup>th</sup> October 2020).
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hours, 2077/06/29 (15th October 2020). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2077/06/29 (15th October 2020) at the office of Birgunj Metropolitan City, Birgunj, Parsa. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 1,50,000.00, which shall be valid for 30 days beyond the validity period of the bid.
7. The Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account Name: Birgunj Metropolitan City, Birgunj, Parsa. Deposit No 12500303000002 at Rastriya Banijya Bank, Birgunj, Parsa.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
