In pursuance of the decision made by the Municipal Assembly of Birgunj Metropolitan City, this public notice is issued to invite Expressions of Interest (EOI) from private sector entities for the management and operation of the New Bus Park Terminal located at Ward No. 16, Birgunj Metropolitan City, under the Public-Private Partnership (PPP) concept for a period of 5 (five) years. The selection of the private partner will be conducted competitively in accordance with the provisions of the Birgunj Metropolitan City Public-Private Partnership Act, 2078, the Public Procurement Act, 2063, Birgunj Metropolitan City Public Procurement Regulations, 2081, Nepal Law Commission Act 2075, Nepal Law Commission Regulation 2077, and other prevailing laws.

Through this notice, EOIs submitted to this office will be evaluated, and a shortlist of eligible applicants will be prepared. Shortlisted applicants will then be invited to submit technical and financial proposals as RFP. Interested private partners are required to submit their EOI through www.bolpatra.gov.np along with the details and documents specified below.

Details:

- 1. Birgunj Metropolitan City has allocated revenue fund towards the cost of Management and Operation of New Bus Park Terminal at Ward No. 16 under Public-Private Partnership (PPP) Concept and intends to apply a portion of this fund to eligible payments under the Contract for which this Expression of Interest is invited for National consulting service.
- 2. The Birgunj Metropolitan City now invites Expression of Interest (EOI) from eligible consulting firms ("consultant") to provide the following consulting services: **Management and Operation of New Bus Park Terminal at Ward No. 16 under Public-Private Partnership (PPP) Concept** Interested eligible consultants may obtain further information and EOI document fee as mentioned below of cost at the address Birgunj Metropolitan City, Office of the Municipal Executive, Birgunj, on or before 2082/09/18(2ndJanuary2026) till 12:00 hours or visit e-GP system www.bolpatra.gov.np/egp or visit the client's website www.birgunjmun.gov.np
- 3. Consultants may associate with other consultants to enhance their qualifications.
- 4. Expressions of interest shall be delivered online through e-GP system $\underline{\text{www.bolpatra.gov.np/egp}}$ on or before $2082/09/18(2^{nd} January 2026)$ till 12:00 hours.
- 5. Expressions of interest shall be opened online through e-GP system www.bolpatra.gov.np/egp on or before 2082/09/18(2nd January2026) at 13:00 hours in the department of Procurement Unit / Procurement Section of Birgunj Metropolitan City.
- 6. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
- 7. EOI will be assessed based on *Qualification [40%]*, *Experience [40%]*, and Capacity [20%] of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal (RFP) through a request for proposal.
- 8. EOIs will be opened in the presence of the applicants or their representatives and relevant authorities. The absence of the applicant's representative will not hinder the opening process.
- 9. Minimum score to pass the EOI is 60.
